Important information before you start trapping: Cats must be dropped off between 8AM and 9AM and picked up by 9AM the morning following surgery. Traps must be covered with a towel or trap cover to reduce the cat's stress while they are in the trap. Do not put anything in the trap other than the cat – no cups, towels, etc. One cat per trap.

Cats must be three months old/weigh three pounds at the time of surgery – this is the minimum age/weight that we can vaccinate against rabies, as required by county ordinance 98-22 and very important to protect the cat and the community.

The TNVR package includes: feline spay or neuter, rabies vaccination, FVRCP vaccination, microchip, ear tip, anesthesia/pain reliever, antibiotic injection and medication to kill fleas/mites.

All cats will be ear-tipped per county ordinance 98-22

Ear-tipping is an effective and universally accepted method to identify a spayed or neutered and vaccinated free-roaming cat. All cats in this program will have their ear tipped. No exceptions. An ear-tip is the removal of the distal one quarter of the cats left ear.

Grant funding currently allows us to offer TNVR at no cost to the community – but funding is limited. Any donation you can make will be greatly appreciated and help us help more animals.

I understand that Palm Beach County ordinance requires ear tipping and microchipping. I agree that each cat spayed/neutered, or deemed previously spayed/neutered, will have the left ear tipped and will be microchipped.
